I am respectfully recommending that a member of this Board make a motion to approve our Principal's establishment of an APPEALS BOARD as the final arbiter of challenges to the Student Athlete eligibility rules.

The Appeals Board's one and only responsibility shall be to meet upon receiving a written mitigation request addressed to the Principal's office from the parents/guardians of a student athlete whose two D or one F grade (****) violated the Student Athlete policy of MICMS. The Appeals Board shall hold a hearing within a reasonable period after the request to decide if there are mitigating circumstances which may have caused the student's failing grades; and by majority anonymous vote decide to allow or continue not to allow a student athlete to participate in the specific athletic program they are involved with. This Appeals Board will have no other jurisdiction and their decisions will be final and non-appealable.

Should the Board vote for the establishment of an Appeals Board, the Principal shall be asked to appoint a 5 (five) member Appeals Board consisting of the three permanent and 2 temporary members:

- (1) The CEO/Principal as the Chair. (Permanent member.)
- (2) Assistant Principal for Curriculum and Instruction as Vice Chair. (Permanent member.)
- (3) Dean of Students. (Permanent member.)
- (4) A faculty member whose course produced the failing grade(s). (Temporarily appointed for the occasion)
- (5) A faculty member whose course produced the failing grade(s). (Temporarily appointed for the occasion)

If only one faculty member's grades are being challenged, the second faculty member will be selected by the Chair.

The Appeals Board shall hold a hearing with the student and his or her parent(s) or guardians at the earliest possible date; deliberate in private and vote anonymously whether the student shall be allowed to participate in athletic teams during the term (***) based on a majority vote. A 3-2 vote shall be deemed a majority vote.

The decision of this Appeals Board shall be final. The decision shall be communicated to the Director of Athletics who will then execute the decision."
